

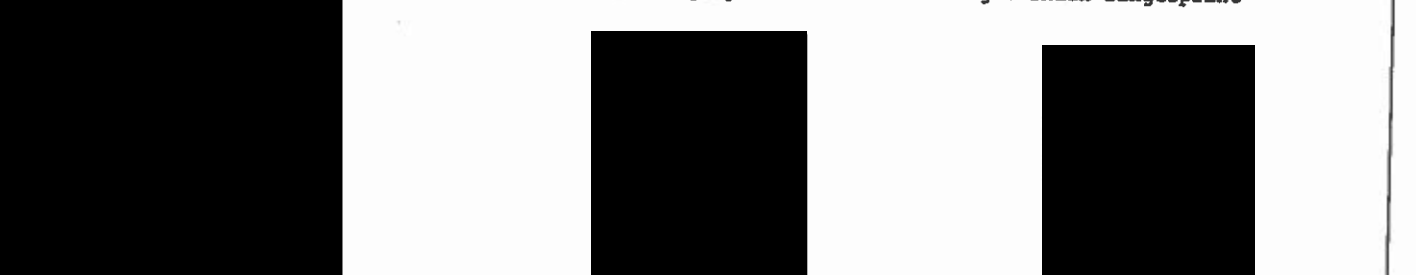

On [REDACTED] 2017, Subject [REDACTED] was arrested by the [REDACTED] County Police Gang unit outside of [REDACTED]. Per [REDACTED] Co. Gang unit this address is being used by Mara Salvatrucha (MS-13). The subject was arrested for making threats of violence towards students at the bus stop located at [REDACTED] waiting to go to [REDACTED] High School. The victim (See [REDACTED] Co. Police Report) stated that the subject and his friends had asked him to join their gang on several occasions, but he refused. On the most recent encounter the subject threatened the victim if he didn't join MS-13, he would be killed. Subject is a validated Associate of MS-13 belonging to the [REDACTED] Clique. ICE was notified of the subject's arrest and gang membership. ICE took custody of the subject upon his release from [REDACTED] County Police. Subject is currently in Immigration proceedings at this time. Subject alienage and deportability has been verified via record checks and interview. During the interview, subject admitted to entering the United States illegally through [REDACTED] Texas in [REDACTED]. Subject is not a citizen of the United States. It has been determined that he is a citizen and national of Guatemala. Subject was taken into ICE custody on [REDACTED] 2017 without incident.
