- Career fairs

#### **Types of Volunteers**

- Law student or non law student
- Part-time or full-time
- Short term or long term
- Funded or unfunded
- School or other credit





#### **Training**

- Orient to agency mission, structure, services
- Train on immigration basics to give context and on specifics of what they will be doing
- Develop a manual and make sure they read it
- Consider streamlining the training program for many volunteers who start at one time
  - -In-person, webinar, self-directed, combo

- Interpretation
- Doc gathering & organization
- Answering calls
- Scheduling
- Outreach

#### Legal

- Public education
- Screening
- Case review
- Legal research
- Legal writing
- Referrals

# Utilizing Volunteel CITIZENSHIP NAVIGATOR

#### Ten Tasks Volunteers can do in a legal setting:

- 1. Assist someone in filling out a form by filling in the blanks exactly as directed
- 2. Translate documents
- 3. Interpretation (i.e., in-person translation of real-time conversations)
- 4. Provide general information about immigration law in a group setting.
- 5. Filing, shredding, copying, scanning and other clerical work
- 6. Fill out intake forms and collect biographical information
- 7. Draft a waiver narrative
- 8. Staff a group processing workshop
- 9. Gather supporting documents for a case
- 10. Prepare photos



## **Utilizing Volunteers**

#### Things to avoid

- Providing a client with a form based on a person's interest in a particular immigration benefit.
- Helping a client fill out an application form by providing your input or opinion on how to answer questions.
- Providing clients with an update on their case using case file information.



# Utilizing Volunteers Why avoid these:

- Your agency can be held liable for the legal work that the volunteers may provide for clients.
- Can provide a chance for an increase in errors on either the forms themselves or even determining eligibility.
- State organizations may investigate the use of uncertified volunteers (paid or unpaid) for legal work as the unauthorized practice of law.
