*This interactive half-day workshop will help prepare legal representatives to successfully represent a client before the asylum office. The workshop is intended for those with little to no experience in the representation of asylum seekers. We will begin with a basic overview of the legal elements required for an applicant to be granted asylum. We will then move on to a small group breakout session involving a mock interview with a client. We will discuss and troubleshoot common issues that can arise when interviewing a client who has suffered trauma. We will then discuss the practicalities of appearing before the asylum office. Next, we will conduct a mock asylum interview and ask for participants' feedback on how to handle challenging situations that might arise during an asylum interview. We will end with participants drafting a closing argument before the asylum office and asking select participants to present their closing arguments to the group.*

<p><b>Navigating Bars to Relief for Afghan Clients</b> <i>Reena Arya, CLINIC; Elizabeth Carlson, CLINIC; Crystal Ortega, Catholic Charities Houston</i></p> <p><i>As Afghan parolees seek permanent residency, asylum, and Temporary Protected Status in the United States, many face intense questioning and scrutiny by USCIS officers on their involvement in armed conflicts and contact with terrorist organizations. In this session, learn the basics on the persecutor bar to asylum, the terrorism-related inadmissibility grounds, and the inadmissibility ground based on extrajudicial killings. We will cover topics such as establishing bona fide marriages, meeting higher standards of proof in some cases, addressing prior marriages and divorce, challenging allegations of fraud, removing the two-year conditions on permanent residency, and anticipating potential ethical issues in representing multiple parties. <p><b>Hot Topics in Parole</b> <i>Jennifer Riddle, CLINIC; Joanna Mexicano Furmanska, CLINIC</i></p> <p><i>In recent years, the Biden administration has increasingly used humanitarian parole to facilitate the orderly entry of certain vulnerable populations without providing them a more lasting immigration status. Some of these programs have left practitioners confused about the appropriate application process and next steps for clients whose periods of parole expire. Other programs have been challenged in federal courts, leaving their futures in question. Join us for a discussion of the latest developments relating to the nationality-specific parole programs, port parole, CAM, and other issues affecting parolees more recently. Exemptions to the English language requirements are available based on the applicant's age and years as a Permanent Resident and there is an exception to the English and/or civics test if the applicant is unable to comply because of a physical or developmental disability or a mental impairment. This panel will discuss recent, proposed changes to the English-speaking test and the civics test and CLINIC's advocacy efforts on this issue.
