Documentation you can start gathering now!

*These lists are for Deferred Action for Parental Accountability (DAPA) or
Deferred Action for Parents of US Citizens and Lawful Permanent Residents*

Applicant Identity Documents

- Foreign Passport
- Foreign National IDs: Matricula Consular, Cedula
- Birth Certificate (with English translation)
- Baptismal Record (with English translation)

Proof of Parentage

- Biological children: birth certificate(s) (with English translation)
- Adoptive children: final adoption decree(s)
- Step children: proof of marriage to child's biological parent prior to age 18
- Children born out of wedlock: evidence of bona-fide parent/child relationship
- Financial Ties-Child support payments, money order receipts, canceled checks
- Emotional Ties-Correspondence of communication with or about the child, photographs of the parent/child relationship
- Other-Medical or insurance records, school records on the child, affidavits from school officials, friends, neighbors attesting to the existence of the parent/child relationship

Proof of US Citizenship of the Child

- US Birth Certificate
- Certificate of US Citizenship
- Naturalization Certificate
- US Passport

Proof of Lawful Permanent Residence of the Child

- LPR Card/Green Card
- I-551 Stamp in Passport or on I-94 Entry Document
- I-797 Notice of Approval

Proof of Continuous Residence from January 1, 2010 to Present

- Complete tax returns including W2s and 1099s
- Paycheck stubs, employment records
- Medical records
- Church records
- DMV records
- School records
- Military records
- Utility bills
- Credit card payment/statements
- Department of Human Services records
- Rental payment receipts/Lease agreements
- Mortgage payment receipts/contract

Proof of Physical Presence in US on November 20, 2014 (and at the time of making your request for consideration of DAPA)

Paycheck stub(s), employment record

Proof of payments, purchases, deposits, transactions or receipts of any kind with applicant name, date and place

List of Residence Addresses from January 1, 2010 to Present

List of Travels Outside the US since Initial Entry

Records from Any Past Immigration Violations Including Apprehensions at the Border

Final Removal/Termination Orders

Detention Records

Current Deportation Proceedings

Any other document issued by the government or Immigration Judge

Records of Any Arrests, Citations, Jail Time, Detentions, Court Proceedings

Police Reports/Arrest Records

Traffic Citations/Tickets

Final Court Dispositions like judgments or Indictments

Criminal and Juvenile Court Documents

Any other paperwork demonstrating what happened

Things to Remember
